5. The tenderers should be reputed contractors and SHG's with wide experience in similar type of work. The tender documents will be issued only to those contractors/ firms who have produced documentary evidence of their experience in this filed to the satisfaction of the officer issuing tenders.
6. The intending tenderers should submit the copies of the latest IT/PAN/GST Registration and experience certificates etc. duly attested, while applying for the same. Tenders will be issued after verification of original certificates.
7. The tenders incorporating additional conditions are liable to be rejected.
8. The intending bidders must have labour registration license/ certificate for arranging PF/ESI etc. except in the case of SHG's.
