## 7. Water Supply schemes under Jaladhare Programme

- Ambitious project to supply treated water from sustainable source(reservoir / rivers) at 55 LPCD service level.
- 4 districts selected in the Phase I namely Vijayapura, Raichur, Dharwad and 3 taluks of Mandya (Pandavapura, K.R.Pete, Nagamangala).
- Planned for External funding from Asian NABARD Infrastructure Denelopment Agency (NIDA).
- 9.04 Lakh rural households benefitting 46.89 Lakh population for ultimate year.

#### 8. Water Supply schemes unde NABARD Programme

- 4 No. Of Projects selected for supplying treated water from sustainable source (reservoir/rivers) at 55
   LPCD service level.
- 4 Projects namely
  - (i) WSS to Satti & 29 Habitations(Chikodi Taluk, Belagavi District)
  - (ii) WSS to Palavanhalli & 60 Habitations(Honnalli Taluk, Chitraduga District)
  - (iii) Holalkere & 223 Habitations(Holalkere Taluk, Chitraduga District)
  - (iv) WSS to Byndoor & 877 Habitations (Byndoor Taluk, Udupi District)
- 1.69 Lakh rural households benefitting 7.38 Lakh population for ultimate year.

## 9. Way Forward to be adopted by Districts / State

- District wise allocation done by the State
- Based on Village Action Plans (VAP) (on tentative line estimates), District Action Plan (DAP) is prepared by the districts
- DAP is approved by DWSM and submitted to SWSM
- Based on DAPs, SAP has been prepared and approved by SLSSC
- SAP approved works will be updated and approved in IMIS at District and State level
- Detailed estimates will be prepared by the districts, and approved in line with delegation of powers and works are tendered as per KTPP
- As and when works are executed and third party inspections, the bills will be raised under 2215 and physical and financial progress will be entered in IMIS
