National Workshop on "Sustainable Rural Housing" as part of Laurie Baker Centenary Celebrations

(23-24 September, 2016)

The concerns of affordability, quality and sustainability will have to be addressed in order to achieve the goal of dignified living for all. Given the broad framework of shelter for all and the flexibility of the programme quidelines of Pradhan Manthri Awaas Yojana – Gramin (PMAY-G), several state governments could come out with state specific schemes on rural housing during the recent past. In spite of the increase in unit of assistance by Govt. of India, top up financial support extended by different state governments, the construction and completion of rural houses remain a major challenge in the implementation of rural housing programmes. Further, the poverty levels of the poor and increase in cost of construction pushed the beneficiaries of rural housing programmes into the debt trap in order to complete the construction of houses. Adoption of cost-effective housing technologies is considered as one of the strategies for effective implementation of IAY as well as ensures the concept of Green Building in the emerging scenario of Sustainable Development. MoRD-UNDP project on Greening Rural Housing is one such intervention apart from the series of workshops on the adoption of cost-effective building technologies as part convergence under MGNREGS. Greening rural housing project has been initiated in Bihar, Meghalaya, Maharashtra, Tripura and Orissa with the help of a few selected consultancy agencies, who have lot of experience in this field. The MoRD has identified A.P., Bihar, Odisha, U.P and West Bengal as IAY focused states for effective implementation of the programme and adoption of region specific cost effective housing technologies. Considering the experience of UNDP states and the need to adopt the same in IAY focused states, it is proposed to organize the present workshop. Further, the proposed workshop is expected to identify the possible strategies that can be adopted for effective usage of local resources and the building material.

Context

The promotion of energy efficient and cost effective technologies is the need of the hour in the context of both achieving the National Mission of "Shelter for All by 2022" and Sustainable Development goals. There are wide range of institutions such as scientific, government and non-government organizations actively involved in not only developing various appropriate technologies but associated with the transfer of the same in the larger context of people's wellbeing. There are a few individuals who have dedicated their entire life in promoting these technologies. Laurie Baker's is one such person, who has not only dedicated but also making these technologies as people's architecture. Since, 2016 has coincided with his Birth Centenary Year and several institutions who are associated with sustainable housing technologies are organizing wide range of events to remember his contributions and provide value addition to facilitate the transfer of these technologies. NIRDPR also proposes to organize a National Workshop on "Sustainable Housing Technologies" to recollect his approaches and contributions to the people's housing and rededicate our involvement in promoting them with a new set of strategies to integrate them with national state specific housing programmes.

The primary objective of the workshop is not only to remember the contributions of Laurie Baker but also to share and discuss to come out with suitable strategies for promoting these technologies in the context of PMAY-G and MGNREGS. The workshop will be held at NIRDPR, Hyderabad during 23 & 24th September 2016. The workshop will be attended by the representatives of all those institutions both government and non-government apart from several scientific institutions and individuals.
