Further, most of the Self Help Group members reach a point where they could not graduate to the next level of entrepreneurship due to various reasons such as lack of financial literacy, requisite management skills, technical knowhow, market linkages, value addition for their products & services, adequate supply of credit, change in the government's policy, etc. In view of the above, this programme is intended to impart training to the field level trainers so that they will improve the skill repertoire of members of SHGs.

### **OBJECTIVES OF THE PROGRAMME**

#### **Broad objective:**

 To enable the participants from SIRDs and ETCs appreciate the best practices in the SHG's model of Microfinance;

#### **Specific objectives:**

- To enable the participants comprehend the latest developments in the financial inclusion space, with special reference to SHG-BLP through classroom interactions and field exposure;
- To help the participants esp., those at the grassroots level understand the nuances of financial inclusion and strive to strengthen the financial inclusion drive.
