#### Mode of ToT:

Physical mode of training at the designated training centre.

#### **Duration of ToT and fee:**

The training duration of the domain training may vary from 3 days to 18 days depending upon the number of ToT course opted by an applicant. Whereas, there is only one platform training of 5 days for one or more domain ToT courses. Domain and platform training put together the total training duration could be 10 days to 22 days (excluding holiday). Multiple training combinations and their fee are proposed below:

An applicant may select one of the above combinations. However, <u>applicant need not pay any ToT fee at the time of submitting application form</u>. They shall wait for the payment related communication from the NIRDPR.

#### Batch size:

The maximum permissible batch size of a ToT course is 20 candidates. However, if the number of candidates at a course goes below 10, then the batch shall not be commenced. The applicants shall be informed accordingly with refund of the fee.

#### **Centre for ToT:**

ToT shall be conducted at Hyderabad. Centre name and location shall be intimated to selected candidates later.

#### **Date for commencement of ToT:**

The commencement date shall be intimated to selected candidates later.

#### Qualification criteria to become a certified Trainer:

Participant must secure at least 90 per cent marks in the Domain training and at least 80 per cent in the Platform to become a qualified trainer for the skill qualification(s) concerned. Inability to secure the desired qualifying marks in Domain training may cause debarment from attending the Platform training.





Please note that, in no condition scores below the prescribed ones shall be considered for certification. Candidate shall have to apply for the ToT afresh with the full payment of fee.

#### ToT certificate:

Certificate shall be issued to the candidates achieved the qualifying marks only, on completion of the ToT. The validity of the certificate is <u>one year</u> from the date of completion of ToT/issue of the certificate.

#### **Must carry list for participants during the ToT:**

#### General:

- (a) Must produce the original identity card to validate the information provided at the application form;
- (b) Must produce original of the evidences attached with the application form;
- (c) Must carry the applicable Personal protective gears (if feels required) to carry out demonstration during ToT

#### Facilities to be provided for the ToT:

- (a) All relevant training materials shall be provided to participants;
- (b) Working lunch shall be provided during the ToT;
- (c) Boarding and Lodging accommodation for the residential facility, transportation and local conveyance <u>have to be arranged and borne by the participants</u>. However, the training centre representative may assist to find out a suitable accommodation near to the training centre and, local conveyance on payment basis for the convenience of the participants, which shall be enquired by selected candidates later.
