In pursuance of instructions received from Government of India, Ministry of Rural Development, New Delhi vide Letter No. Lr.No. K-15017/17/2007-Trg.-Part.II, dt.24.7.2012 (Ref-1), a proposal on amendment/ addition to Rule III of Rules of NIRD, 1991 to include Additional Secretary, Department of Rural Development, Government of India, as Ex-Officio Member of General Council was placed before the General Council of the Institute in its 60<sup>th</sup> meeting held on 11.07.2013. Earlier, an agenda on the matter was circulated and approved by Executive Council in terms of Rule X(xiii) of Rules of NIRD. Approval from Chairman of Executive Council was also received on the matter vide Ministry of Rural Development Letter No.K-15017/1/2012-Trg., dt.24.12.2012 (Ref-2).
