MEMORANDUM

The undersigned proposes to hold an inquiry against Dr.E.V.Prakash Rao, Professor (under suspension) under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965. The substance of the imputations of misconduct or misbehaviour in respect of which the inquiry is proposed to be held is set out in the enclosed statement of articles of charge (Annexure-I). A statement of the imputations of misconduct or misbehaviour in support of each article of charge is enclosed (Annexure-II). A list of documents by which, and a list of witnesses by whom, the articles of charge are proposed to be sustained are also enclosed (Annexures - III and IV).

2. Dr. EV Prakash Rao is directed to submit, within 15 days, of the receipt of this Memorandum, a written statement of his defence and also to state whether he desires to be heard in person.

3. He is informed that an inquiry will be held only in respect of those articles of charge as are not admitted. He should, therefore, specifically admit or deny each article of charge.

4. Dr.E.V.Prakash Rao is further informed that if he does not submit his written statement of defence on or before the date specified in Para 2 above, or does not appear in person before the inquiring authority or otherwise fails or refuses to comply with the provisions of Rule 14 of the CCS(CCA) Rules, 1965, or the orders/directions issued in pursuance of the said rule, the inquiring authority may hold the inquiry against him ex parte.

5. Attention of Dr.EV Prakash Rao is invited to Rule 20 of National Institute of Rural Development (Conduct) Rules read with Rule 20 ofCentral Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings, it will be presumed that Dr.EV Prakash Rao is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rules 20 of the CCS(Conduct) Rules, 1964.

6. The receipt of the Memorandum may be acknowledged.

ARTICLE - I

That the said Dr. E.V. Prakash Rao while functioning as Professor in the Eastern Regional Centre (ERC), NIRDPR, Patna conducted 15 training programmes during the February 2013 to February 2015, for which he had addressed a period between communication to one AkhilaBharatiyaPanchayati Raj VikasSansthan (ABPRVS) every time before commencement of the training programme requesting to make arrangement for venue, boarding and lodging for the participants and at the same time he authenticated and processed the bills for payment amounting to Rs.61,08,060 (Rupees Sixty One Lakh Eight Thousand and Sixty only) in the name of New Nilima Tent House and Caterers. However, on enquiry it has been revealed that the nine training programmes were conducted at Gandhi Sangrahalaya, Patna for which an amount of Rs.76,000/- (Rupees Seventy Six Thousand only) was alone paid by him. Dr.Prakash Rao concealed the fact of conducting the training programmes in Gandhi Sangrahalaya and failed to bring on record about conducting the training programmes at Gandhi Sangrahalaya and the payments made thereon to them. But the said Dr. E.V. Prakash Rao had authenticated and processed the bills in the name of New Nilima Tent House and Caterers amounting to Rs.61,08,060 (Rupees Sixty One Lakh Eight Thousand and Sixty only) for payment by acknowledging on each of the bills that he himself paid the amount in cash. He portrayed as if New Nilima Tent House and Caterers had made all the arrangements through ABPRVS while hiding the fact that an amount of Rs.76,000/- (Rupees Seventy Six Thousand only) was already paid to Gandhi Sangrahalaya. It is also observed that the bills of NewNilima Tent House and Caterers were almost serially issued during the period of February 2013 to February 2015 which indicates that there are no other bills issued by the firm during that period as if there are no other customers except Dr.E.V.Prakash Rao. From the above it is established that Dr. Prakash Rao had conducted nine training programmes at Gandhi Sangrahalaya but authenticated and processed the fictitious bills in the name of New Nilima Tent House and Caterers amounting to Rs.61,08,060 (Rupees Sixty One Lakh Eight Thousand and Sixty only) while concealing the fact that he paid a nominal amount to Gandhi Sangrahalaya. It is clear that he did not conduct any training at New Nilima Tent House and Caterers and thus amounted to breach of trust by government employee, misappropriation of government funds, failure to maintain high ethical standards and honesty, acted contrary to law, rules, regulations and established practices, misused of his

position as government servant failed to perform / discharge his duties with highest degree of professionalism and his conduct is prejudicial to the interests and reputation of the Institute and the said acts and conduct constitute to failure to maintain absolute integrity, devotion to duty, unbecoming of a government servant and thus violated Rule 3 (1) (i) to (iii) of NIRD Employee (Conduct) Rules.

<u>ARTICLE – II</u>

That the said Dr. E.V Prakash Rao while functioning as Professor in ERC, NIRDPR, conducted training programmes at ERC-Patna. For the programmes conducted during February 2013 to February 2015, and settled the bills submitted by New Nilima Tent House and Caterers for 9 programs amounting to Rs.34,06,250/- (Rupees Thirty four lakhs six thousand two hundred fifty only) towards venue, boarding and lodging facilities wrongfully claiming that he had provided these facilities to all the participants in the 9 trainings. Dr.E.V. Prakash Rao claimed expense @ Rs.1,250/- (Rupees One Thousand Two Hundred and Fifty only) per person per day towards venue, boarding and lodging. He authenticated and processed the bills for an amount of Rs.34,06,250/- (Rupees Thirty four lakhs six thousand two hundred fifty only). However, from the feedback received from the participants of the training program, it is confirmed that the venue for training was in the Institutions like Gandhi Sangrahalaya which was confirmed vide their letter No.33/1066/2018-18 dt.30.05.2018 and stated that during that period 9 trainings were conducted in their premises and venue charges for each training program was paid by NIRD. The facilities for boarding and lodging were not arranged at the Institution where trainings were actually conducted. Dr. E.V. Prakash Rao provided only working lunch and tea from an outside agency as per the written statement of Shri Bhagwan Singh Dobal, Draughtsman, one of the witnesses as well the feedback received from the trainees. The cost of working lunch and tea if ordered in bulk at Patna would be around Rs.150/- (Rupees One Hundred Fifty only) per person per day which was said to have been provided during the days which works out to Rs.4,08,750/- (One Four lakhs eight thousand seven hundred and fifty only). Thus, the total cost on venue, boarding & lodging for these nine training programs would be Rs.4,84,750/- (Rs.4,08,750 + Rs.76,000).

From the above, it is clear that he misappropriated an amount of Rs.29,21,500/-(Rupees Twenty nine lakhs twenty one thousand five hundred only) (Rs.34,06,250 – Rs.4,84,750) from only 9 training programmes. Dr.EV Prakash Rao had authenticated and processed these fictitious and inflated bills for payment and thus misused his official position as Government servant taking decisions in order to derive financial benefits for himself. Thus he failed to maintain high ethical standards and honesty, acted contrary to law, rules, regulations and established practices, misused his position as government servant and failed to perform / discharge his duties with highest degree of professionalism and his conduct is grossly immoral that all reasonable men will say that the employee cannot be trusted and the Institute cannot rely on his faithfulness and the said acts and conduct constitute to failure to maintain absolute integrity, devotion to duty and behaved in an unbecoming of a Government servant and thus violated Rule 3 (1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employee (Conduct) Rules.

<u>ARTICLE – III</u>

That the said Dr.EV Prakash Rao while functioning as Professor in ERC, NIRDPR, conducted training programmes at ERC-Patna during February 2013 to February 2015 and settled the bills in the name of Om Sai Tours & Travels, Patna amounting to Rs. 12,50,117/-(Rupees Twelve Lakhs Fifty Thousand One Hundred and Seventeen only) towards the hiring of vehicle charges. On verification of the bills, it is seen that Dr.Prakash Rao had authenticated and processed the bills for paymentfor two programmes conducted during December 2014 to February 2015 and amount of Rs. 1,76,632/- (Rupees One Lakh Seventy Six Thousand Six Hundred and Thirty two only)was shown as paid towards hiring of vehicles. On close scrutiny of the registration numbers of some of the vehicles through Vahan website it has come out that the registration numbers of the vehicles in the bills do not correspond/tally to the registration numbers allotted by the Regional Transport Officer (RTO). The vehicle numbers in these billsaccording to the Vahan website of RTO shows that these registration numbers pertain to three wheelers / two wheelers / tractors or busses and not that of the registration numbers allotted to the vehicles mentioned in the bills(Sumos/ Boleras/ Indica). However, Dr.Prakash Rao had authenticated and processed the claims amounting to Rs.24,250/-(Rupees Twenty four thousand two hundred fifty only) towards the transport hiring charges while he actually did not hire these vehicles. However, he authenticated and processed the fictitious bills with fake registration numbers. Dr.Prakash Rao has thus misused his official position as Government servant and took decisions in order to derive financial benefits for himself in excess of powers conferred on him acting otherwise than in his best judgment and failed to maintain high ethical standards and honesty, acted contrary to law, rules, regulations and established practices, misused his position as government servant. By his above misconduct, all reasonable persons will say that the employee cannot be trusted and the Institute cannot rely on him and the said acts and conduct constitute to failure to maintain absolute integrity, devotion to duty, unbecoming of a Government servant and thus violated Rule 3 (1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employee (Conduct) Rules.

ARTICLE-IV

That the said Dr.EV Prakash Rao while functioning as Professor in ERC, NIRDPR, Patna conducted training programmes at ERC-Patna during the period from February 2013 to February 2015. On cursory check of the bills pertaining to two training programmes conducted during December 2014 and February 2015 it is noticed that he had settled the bills towards hiring of vehicles from Om Sai Tours and Travels towards transportation at a uniform mileage of 400 kms per day. However, no breakup travel details were shown in the bills. Assuming that transportation facility was provided daily during the period of training for a maximum of two / three resource persons, the total mileage works out toa maximum of 75kms only per day considering the distance travelled by the resource persons from their residence / work place to the place of venue (Gandhi Sangrahalaya or New Nilima Tent House and Caterers) and back, based on the distance details obtained from the Google Maps. Thus, the fictitious bills were authenticated and processed by him for payment involving an additional mileage of 325 km per day for 11 days pilfering an amount of Rs.65,000/- (Rupees Sixty five thousand only)with escalated mileages of 3,575kilometres pertaining to two training programmes conducted during December 2014 and February 2015 alone. This is only indicative since Dr.Prakash Rao had conducted 32 programs since January 2012 for all of which the bills were authenticated and processed by him from Neelu Tours and Travels / Om Sai Tours and Travels for which bills were submitted for each training. The above acts of Dr.Prakash Rao amounted to misuse of his official position as Government servant and taking decisions in order to derive financial benefits for himself failing maintaining of high ethical standards and honesty. Thus he failed to maintain absolute integrity, devotion to duty and had violated Rule 3 (1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employee (Conduct) Rules.

ARTICLE-V

That the said Dr. E.V. Prakash Rao while functioning as Professor in ERC, NIRDPR, Patna conducted 17 training programmes at ERC-Patna between April 2012 and February 2015. It is noticed that he had settled the bills towards hiring of vehicles from Neelu Tours and Travels / Om Sai Tours and Travels towards transportation of participants for field visits at an uniform mileage of 400 kms per field trip for the above 17 programmes though the field trips were to different locations on different occasions from the place of venue. On verification of the details of the distance covered during the 17 field visits it was noticed that a total distance of 56,800 kms was shown as covered for the said field visits. However, the total mileage actually comes to 42,141 Kms only as per the route map and the distance mentioned in the Google Maps. Thus, an additional mileage of 14659 kms was added in the bills which were authenticated and processed by him. Thus, an additional amount of Rs. 1,39,260/- (Rupees One lakh thirty nine thousand two hundred sixty only) was processed for payment by him by escalating the mileage in the fictitious bills for pilferage of the Government money. Thus the acts and conduct of Dr.Prakash Rao amounted to misuse of his official position as Government servant and taking decisions in order to derive financial benefits for himself in excess of powers conferred on him, failed to maintain high ethical standards and honesty, acted contrary to law, rules, regulations and established practices, misused of his position as government servant. Dr.Prakash Rao had thus failed to maintain integrity and devotion to duty and became unbecoming of a Government servant violating Rule 3 (1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employee (Conduct) Rules.

<u>Statement of imputation of misconduct or misbehaviour in support of the Articles of</u> <u>Charge framed against Dr.Prakash Rao, Professor, NIRDPR (under suspension).</u>

ARTICLE -I

Dr. E.V. Prakash Rao while functioning as Professor in ERC, NIRDPR conducted 15 numbers of training programmes during the period February 2013 to February 2015 and settled the bills submitted by New Nilima Tent House and Caterers, Patna through AkhilaBharatiyaPanchayatiRajVikasSansthan (ABPRVS) amounting to Rs.61,08,060(Rupees Sixty One Lakhs Eight Thousand and Sixty only) towards hiring of venue and for providing boarding and lodging to the participants. After conducting the training programmes,Dr.EV Prakash Rao submitted bills of New Nilima Tent House and Caterers for providing venue, boarding and lodging facilities duly authenticating the bills as per the details indicated below:

Based on a complaint dated 27-11-2014, Central Bureau of Investigation, Hyderabad directed NIRD&PR to investigate the matter. On inquiry it has come out that out of the 15 programmes conducted, 9 training programmes were conducted by Dr.EV Prakash Rao at Gandhi Sangrahalaya, Patna. Secretary, Gandhi Sangrahalaya, Patna vide his Letter No.

33/1066/2018-18 dated 30/05/2018 confirmed that an amount of Rs. 76,000/- (Seventy Six Thousand only) was received by them towards booking of Conference Hall by NIRDPR, ERC, Patna as per the details indicated below:

To establish the identity and capability of the New Nilima Tent House and Caterers, Patna, necessary enquires were caused through internet and it was found that besides the name of the establishment (i.e., New Nilima Tent house & Caterers written in Hindi), it contains the Phone Number as (9334541292) and the name of the proprietor is mentioned as Rajesh Kumar. The Phone Number and the name of the proprietor corresponds exactly with the phone number and proprietor on the bills of New Nilima Tent house & Caterers which were duly signed and certified as paid in cash by Dr. EV Prakash Rao based on which the bills were cleared and cheques wereissued in his favour.

The photo of New Nilima Tent house & Caterers shows that it is just a Tent house. It is too small to have a conference hall. It is clear it had no kitchen to provide breakfast, lunch, dinner, tea & snacks to nearly 50 participants at a time. It is also seen that the bills of New Nilima Tent House & Caterers were almost serially issued as if there were no other bills by the firm during the above period. It means that New Nilima Tent House & Caterers had no other customers except Dr.Prakash Rao and the bills processed by Dr.Prakash Rao are fictitious.

From the above, it is evident that Dr. Prakash Rao had conducted 9 training programs at Gandhi Sangrahalaya, Patna. He, however, authenticated and processed the fictitious bills in the name of New Nilima Tent House & Caterers for an amount of Rs.61,08,060 (Rupees Sixty One Lakhs Eight Thousand Sixty only).Dr. Prakash Rao never brought on record about the bills paid to Gandhi Sangrahalaya even though he had actually conducted 9 programs in this Institute and paid an amount of Rs.76,000(Rupees Seventy Six Thousand only) to them. The fact of not brining the payments made to Gandhi Sangrahalayaon record and authenticating and passing the inflated fictitious bills in the name of New Nilima Tenthouse & Caterers indicates his malafide intentions for personal illegal financial benefits violating Rule 3 (1) (i), (ii) and (iii) of NIRD Employees (Conduct) Rules.

ARTICLE - II

Dr. E.V. Prakash Rao while functioning as Professor in NIRDPR, ERC conducted training programmes at Patna during the period from February 2013 to February 2015. For the9 programmes conducted during the period,Dr.Prakash Rao had settled the bills submitted by New Nilima Tent House and Caterers amounting to Rs.34,06,250/- (Rupees Thirty four lakhs six thousand two hundred fifty only) towards the charges for venue, boarding and lodging facilities claiming that he had provided these facilities to all the participants in the nine trainings as indicated below:

The list of participants in the training programs were enclosed by him indicating their phone numbers and name of the district. A phone call was made to the trainees at random to findout the details of facilities provided to the participants. All those who could be contacted said that no boarding and lodging except working lunch and tea were provided during training days.

Many of the participants informed that they were from Patna only though in the training details they were shown hailing from various parts of Bihar like Samastipur, Madhubani, Jamui, Munger, Lakhisaria, Motihari, Dabangha, Bettia, Jamui, Sekhpura etc. Further they have informed that they were only provided with working lunch and tea during the days of training.

From the above it is confirmed that usual accommodation and food was not arranged during the entire period of trainings. Mr.Bhagwan Singh Dobal, Draughtsman who was assisting Dr.Rao in conducting the trainings confirmed in writing that only working lunch and tea were provided in each training during the above three training programmes.

However, Dr.EV Prakash Rao had authenticated and processed the claims for an amount of Rs.34,06,250 (Rupees Thirty four lakhs six thousand two hundred and fifty only) towards lodging, boarding and other expenditure for training days in each programme at Rs.1,250 per day per trainee for all the participants in nine training programs as indicated by him. It is confirmed that the venue for training was in the Institution Gandhi Sangrahalaya, Patna. The venue charges for each training program were paid to Gandhi Sangrahalaya as confirmed by them vide their letter No.33/1066/2018-18 dt.30.05.2018. The facilities for boarding and lodging were not arranged at the Institutions where trainings were actually conducted. Dr.E.V. Prakash Rao provided only working lunch and tea from an outside agency. The cost of working lunch and tea if ordered in bulk at Patna at that time would be around Rs.150/- (Rupees One Hundred Fifty only) per person per day which was claimed to have been provided for seven days of training working out to Rs.4,08,750/- (Rupees four lakhs eight thousand seven hundred and fifty only). Thus, the actualtotal cost on venue, boarding & lodging for these three training programs would be not more than Rs.4,84,750/-. From the above, it is clear that he pilfered the amount around Rs.29,21,500/- (Rupees Twenty nine lakhs twenty one thousand five hundred only) (Rs.34,06,250 - Rs.4,08,750) which amounts to 86 per cent of the amount sanctioned and paid in cheque to Dr.Prakash Rao for the nine training programs as detailed below:

He had thus involved in irregular financial transactions and exhibited lack of integrity, devotion to duty and also behaved in a manner of unbecoming of a Government Servant violating Rule 3(1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employees (Conduct) Rules.

ARTICLE III

Dr. EV Prakash Rao while functioning as Professor in ERC, NIRDPR, conducted training programmes at ERC-Patna during February 2013 to February 2015 and settled the bills in the name of Om Sai Tours & Travels, Patna amounting to Rs. 12,50,117 (Rupees Twelve Lakhs Fifty Thousand One Hundred and Seventeen only) towards the hiring of vehicle charges for the above training programmes. On verification of the bills, it is noted that Dr.Prakash Rao had authenticated and processed the bills for an amount of Rs.1,76,632 (One Lakh Seventy Six Thousand Six Hundred Thirty Two only) in respect of two programmes conducted during December 2014 to February 2015. The bills indicated the hired vehicle types as Sumo/Bolero/Indica. On close scrutiny of the registration numbers of mentioned bills through "Vahan" some of the vehicles in the website(http://vahan.nic.in/nrcservices/faces/user/isp/SearchStatus.jsp) it has come out that the registration numbers of the vehicles mentioned in the bills do not belong to these vehicles and the vehicles with these registration numbers are either three wheelers / two wheelers / tractors or busses. A Statement indicating the details of the vehicles said to have been engaged and the real status of these vehicles is indicated below.

From the above, it is clearly established that the type of vehicles mentioned in the bills is fabricated and the vehicles with the registration numbers indicated in the bills were

not at all hired by Dr.EV Prakash Rao.ButDr. Raoauthenticated and processed the false claims towards hiring of vehicles by fabricating the vehicle details amounting to Rs.24,250 (Rupees Twenty four thousand two hundred fifty only).

The total amount of vehicle hire for these two programs amounted to Rs.1,76,632/only and the amount clearly pilfered as mentioned in the last para is Rs.24,250/-. This does not mean that the balance amount of (Rs.1,76,632 - Rs.24,250) Rs.1,52,382/- was paid for actual hiring. When the details of the other vehicles mentioned in the bills were verified with Vahan website of the RTO, it was mentioned that the details were not digitized or the numbers furnished were wrong. There is every possibility that a large chunk of Rs.1,52,382/could have been pilfered.

It is however confirmed that Dr.Prakash Rao had pilfered an amount of Rs.24,250/- or possibly even more. Dr. Prakash Rao thus shown lack of integrity, devotion to duty and also behaved in a manner of unbecoming of a Government Servant violating Rule 3(1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employees (Conduct) Rules.

ARTICLE - IV

Dr. EV Prakash Rao while functioning as Professor in ERC, NIRDPR, Patna conducted training programmes at ERC-Patna during the period from February 2013 to February 2015. On cursory check of the bills pertaining to two training programmes conducted during December 2014 and February 2015 it is noticed that he had authenticated and processed the bills towards hiring of vehicles from Om Sai Tours and Travels towards transportation at a uniform mileage of 80 km for 5 vehicles per each day thus totalling to 400 kms per day without indicating the breakup travel details in the bills. He claimed to have hired 5 vehicles for 5 days for each training. Assuming that transportation facility was provided during the period of training for Resource Persons of 22 trips, a distance of 85 kms only wouldbe adequate to service the Resource Persons. This is as per the assumption that the distance travelled by the resource persons from their residence / work place to the place of training and back. Thus, the bills were authenticated and processed for an additional mileage of 3575 kms(2 trainings) pilfering an amount of Rs.71,500(Rupees seventy one thousand five hundred only) with escalated mileages of 3,575kilometres pertaining to the above two training programmes.

From the above, it is evident that escalated bills towards hiring of the vehicles were authenticated and processed for the total mileage of 44,000 kilometres instead of 825 kilometres during days of training and pilfered an amount of Rs. 71,500 (Rupees seventy one thousand five hundred only). Thus Dr. Prakash Rao has exhibited lack of integrity, devotion to duty and also behaved in a manner of unbecoming of a Government Servant violating Rule 3(1) (i), 3 (1) (ii) and 3 (1) (iii) of NIRD Employees (Conduct) Rules.

ARTICLE-V

Dr. EV Prakash Rao while functioning as Professor in ERC, NIRDPR, Patna conducted training programmes at ERC-Patna during the period from April 2012 to February 2015. On scrutiny of the bills pertaining to 17 training programmes conducted during April 2012 and February 2015, it is noticed that he had settled the bills towards hiring of vehicles from Neelu Tours and Travels / Om Sai Tours and Travels towards transportation of participants for field visit at a uniform mileage of 400 km per trip though the field visits were to different places on different occasions. On further verification of the details it was noticed that a total distance of 6800 kms was shown as covered for the said field visits. The total distance comes to 4428 kms only based on the route map and the distance mentioned in the google maps for the said field visits. Thus, an additional distance of 13859kms was added in

the bills and subsequently authenticated and processed an additional amount of Rs. 131660 (Rupees One lakh thirty one thousand six hundred sixty only) by Dr.EV Prakash Raofor payment as detailed below.
