#### BACKGROUND

Senior citizen population is a global phenomenon. One of the undeniable fact of Human life is that the ageing process is basically normal. A central concept in any discussion ageing is the meaning of age itself. The senior Citizens as per the United Nations are referred to as people of 60 years of age and above. In Indian context also the same reference is being followed.

The main problem with Senior Citizens in India is poverty and nearly 70% of the Senior Citizens live in the rural areas and who works in the subsistence economy. Because of the elderly persons have little or no money, they suffer from malnutrition leading to depression and confusion. In addition to problems of illiteracy, unemployment, Widowhood and disabilities, Older Women in India also face life-long gender based discrimination, resulting in differential patterns of ageing of men and women. The global demographic trend indicates that the ageing of the World population is progressive and rapid. As long as fertility continuous to fall or remain low and old age mortality keeps on declining, the proportion of Senior Citizens will continue to increase.

Population ageing has profound social, economic and political implications on society. The increasing number of older persons put a strain on health care and social care systems in the country. A sizeable portion of money is spent on meeting requirement of old age population. Government, thus, has to face the double whammy. On one side the resources are shrunk, on the other, expenditure is increased. To face the challenges of ageing population, the country needs to be well prepared for older population to adapt to a changing society.

Suitable redistributive policies are required. New priorities must be added to the scarce resources for social programs for elderly, while still having to deal with the problems of the younger populations. Women issues also are of paramount importance in considering social policies for elderly population. Appropriate care and support for them is a priority.

In order to deliberate on different aspects of policy and research for improving the Quality of life of Senior Citizens, the Centre for Equity & Social Development, National Institute of Rural Development & Panchayati Raj is proposing to organize a two-day National Seminar on October 03-04.2019 in connection with the observance of International Day of Older People - 2019 on "Quality of life of Senior Citizens". The day is celebrated annually to recognize the contributions of older persons and to examine issues that affect their lives.

In view of the above, this National Seminar proposes to bring insights from divorce disciplines and seeks to relocate development in the framework of Social Justice and promoting Human Rights especially for improving the quality of life of Senior citizens in a sustainable way.
