NEED:

The Government of India has recognized that the Non-Governmental Organisations (NGOs) are playing important role in the socio-economic development of the rural poor in our country. The advantage of such organization is that they could operate in most difficult areas and exercise freedom of planning and implementation of the development programmes addressing local needs. The success of NGO movement is linked with the better rapport with stakeholders and proximity of working with the target groups. But they are also having difficulties in identifying appropriate problem and preparation of viable proposal to the funding agencies and government sponsors. It is observed that a good number of NGOs are looking for opportunity upgrade necessary skills and competency for preparing right type of project for getting appropriate funding support from the donor agencies. As a result of which, efficient field action oriented small grassroot organisations are being deprived and unable to fulfil the needs of the funding sources. Considering the current needs of development, It is necessary to orient these NGOs in sustainable development approach aligning with the nation's present priority of development especially localization SDGs in to rural development. Further mentoring is also needed for NGOs working as partner with rural local bodies for achieving concentrated development. With this backdrop, NIRD *being* an apex rural development training institute, deem it necessary to conduct training programme to improve the competencies of grassroot level upcoming organizations in the subject areas of problem identification,

project preparation, proposal writing, Finding resources and effective management of resources for achieving SDGs.
