



## ToT Programme on Mahatma Gandhi NREGS Financial Management: PFMS, DBT and Aadhar Seeding September 26-30, 2022



The Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is one of the unique employment generation programmes in India, aiming to augment rural livelihood security by creating sustainable natural and human made assets, through public and individual works. Wages will be made through DBT to individual accounts by using Aadhar Seeding and Public Financial Management System.

Public Financial Management System (**PFMS**) is a web based application in online management of information and decision support system for the schemes of the Government of India and the State government. The purpose of this system is to track and monitor the fund disbursement and utilization on real time basis. It is a common electronic platform for complete tracking of fund flow from the Government to large number of programme implementing agencies (PIAs) until it reaches the final intended beneficiaries.

PFMS promotes transparency and tangible improvements in the overall MGNREGS financial management and implementation of scheme with collateral benefits of plugging leakages and eliminating ghost beneficiaries. The recent REATS (Receipts, Expenditure, Advances and Transfers) module of PFMS is meant for capturing all the expenditures and receipts of agencies which are in receipt of funds from Government of India directly, State Government or through their parent agencies.

Keeping in view of this importance, NIRDPR has designed a capacity building ToT programme to strengthen the capacities of officials dealing with PFMS at various levels/schemes in implementation. The present capacity building ToT programme focuses on **MGNREGS Financial Management - PFMS, DBT and Aadhar Seeding**. The ToT programme also aims to elaborate different aspects of PFMS, DBT and Aadhar seeding by taking examples of Mahatma Gandhi NREGS.

### OBJECTIVES OF THE ToT PROGRAMME:

- . To impart basic understanding on PFMS, DBT and Aadhar seeding for effective implementation of Mahatma Gandhi NREGS.
- . To introduce methods of Mahatma Gandhi NREGS Financial Management for effective implementation.
- . To enhance capacity and to sensitize participants working for Mahatma Gandhi NREGS towards financial management.
