Experience

Retired employees of Indian Audit & Accounts Department, with field experience in transaction and Performance audit.

Consolidated Remuneration:

Their remuneration will be regulated as per Government of India, Ministry of Finance [OM NO. F.No.3-25/2020-E.IIIA](#), dt.9.12.2020 issued for regulation of Remuneration in case of Contract Appointment of Retired Central Government Employees, ie., Basic Pay at the time of retirement minus Pension.

A fixed amount towards Transport allowance will be paid in addition to the remuneration, as mentioned above, as per OM *ibid*.

No increase in remuneration is allowed during the contract period, as per OM *ibid*.

Quarters

NIRDPR Staff quarters which are within the NIRDPR Campus can be allotted, on request and subject to availability and payment of rent will be charged as per norms.

Age:

As per the above [OM NO. F.No.3-25/2020-E.IIIA](#), dt.9.12.2020 of Ministry of Finance, the retired employees cannot be employed beyond 5 years after superannuation.

Candidates should not have crossed 63 years of age.

General conditions:

Term of engagement: The engagement is purely on temporary basis on contract which will be initially for a period of one year. Further extension can be considered based on performance and Institute's requirement.

The candidate should be willing to travel to Branch Offices of NIRDPR and work upto late hours and on holidays as per emergent office requirements.

A screening test will be conducted.
