Recruitment of Three Consultants (On Project Mode)

1. About the Center

It's widely recognized that transparency, accountability and people's participation especially in development programmes lead to more effective outcomes. Social Audit is a powerful tool that helps achieve this and there has been increasing demand for introduction of social audit in different schemes by the stakeholders.

Section 17 of the MGNREG Act, 'Social Audit of work by Gram Sabha' states that the Gram Sabha shall conduct regular social audits of all projects taken up under the Scheme within the Gram Panchayat (GP). Social audits are now made mandatory in many Rural Development programmes including PMAY-Grameen and NSAP. Ministry of Panchayati Raj has recommended social audit of the Fourteenth Finance Commission Grants. National Food Security Act, 2013 and Rights of Persons with Disabilities Act, 2016 also mandate social audit.

To facilitate effective social audits, The Ministry of Rural Development in consultation with the Comptroller and Auditor General of India drafted the MGNREG **Audit of Schemes Rules**, 2011 iThe Rules mandate that State Government shall identify or establish an independent organization (Social Audit Unit) to facilitate conduct of social audit by Gram Sabhas. In 2016, the Ministry again in consultation with the C&AG published the auditing standards for social audit.

To provide technical support to the Social Audit Units in States, Center for Social Audit of National Institute of Rural Development and Panchayati Raj (NIRD&PR) Hyderabad will be manned by Social Audit Consultants with funding support from Ministry of Rural Development.

The overall objective of CSA is to equip and support the social audit units and create a cadre of committed social audit resource persons to carry out social audits effectively in all the development programmes.

Thus CSA at NIRD&PR is mandated to set in place mechanisms for performing all the above functions by recruiting **Three Social Audit Consultants**. The social audit consultants will be recruited purely on temporary basis and on contractual term for a period of **One Year** and **extendable up to another Two Years**.

2. The Mandate of Social Audit Consultants

The Social Audit Consultants are responsible for liaising with State Social Audit Unit under MGNREGS and conduct

- Training need assessment (TNA), Preparation of training module and material on social audit
- Training of master trainers (for PMAY–G, NSAP and other development programmes) and training of social audit resource persons in the states; Impact assessment of training and Certification of the trainers.
- Training of state, district and block level trainers/ resource persons, Sensitization of Officials and PRIs,
- Take up Pilot / Test social audits of schemes like MGNREGS, PMAY, NSAP, PDS, MDM, FFCG etc. in selected GPs
- Develop key performance indicators to evaluate the effectiveness of social audit process and performance of social audit units.
- Develop formats to capture social audit findings, action taken reports and help build good MIS to monitor and track the social audit process
- Analyze social audit processes and findings from different states and schemes and make recommendations for improving the implementation of the schemes.
- Create and manage knowledge repository on social audit/ social accountability including a website on social audit:
- Develop good IEC material including pamphlets and short films for knowledge dissemination
- Facilitate setting up and mentoring of Social Audit Units in collaboration with the State Governments as per Auditing Standards.
- Liaison with other ministries / institutions for providing professional support as and when required. Engage in policy advocacy to take forward the agenda of social audit by networking with other like-minded institutes.
- Develop online / distance certificate programmes on social accountability mechanisms and social audit so that there will be no dearth of trained personnel and also provide opportunity for others who want to learn about social audit.
- Undertake research in the area of social accountability and social audit to support policy making. In addition, document case studies of successful initiatives.
- Organize seminars, workshops and exposure visits on social audit periodically.

Thus to perform above tasks, the Social Audit Consultants are required to travel extensively across the country.
