The Centre for Wage Employment (CWE) and the Centre for Social Audit (CSA) of NIRD&PR, is recruiting Research Associates, Training Managers, Senior Consultants and Project Assistants for temporary project positions. The appointment is for one year and extendable to a maximum period of three years depending on performance. The salary, educational qualifications and experience is detailed below:

## 1. Specific Job Requirements:

### a. Training Managers (CSA and CWE)

Facilitating and assisting the faculty in organizing national and international level training programmes. The candidates should have through understanding on training related activities. They are also required to maintain documentation on training programmes, including budget, training reports, and evaluation of training programmes on MGNREGS, facilitating field visits and possessing sound knowledge.

## b. Research Associates (CWE)

Facilitating and assisting the faculty in research related activities. The candidates should have through understanding on research methodology, statistical, econometric analysis and report drafting skill. They are also required to travel extensively at national level.

### c. Consultants (CSA and CWE)

- (a) Senior Consultant, CSA will be responsible for liaising with State Social Audit Unit under MGNREGS and conduct
- Training of Trainers (TOT) on Social Audit for Rural Development Flagship programmes and in other development programmes as per the demand
- Take up Training need assessment (TNA), Preparation of training module and material on social audit Training of master trainers at National level (for each development programme) Training of state, district and block level trainers/ resource persons, Sensitization of Officials and PRIs, Impact assessment of training and Certification of the trainers.
- Take up Pilot / Test social audit for the schemes like MGNREGA/ PMAY/IWMP, FFCG/NSAP/NFSA/ICPS etc
- Create and manage knowledge repository on social audit/ social accountability

- Liaison with other ministries / institutions for providing professional support as and when required.
- Develop online/ distance certificate programmes on social accountability mechanisms and social audit.
- Undertake research in the area of social accountability and social audit which helps in the policy decision taking. Document case studies of successful initiatives
- Organize seminar, workshops, exposure visits time to time for exchange of experience and learnings on social audit.

Thus to perform above tasks, the Consultant, CSA is required to travel extensively across the country.

## (b) Senior Consultant, CWE will be responsible for

- Take up Training need assessment (TNA), Preparation of training modules and material on MGNREGS
- Monitor and take evaluation of on going Training programs at State level.
- Liaison with other ministries / institutions for providing professional support as and when required.
- Organize seminar, workshops, exposure visits time to time for exchange of experience and learnings on social audit.

Thus to perform above tasks, the Consultant, CSE is required to travel extensively across the country.

#### d. Project Assistants (CWE)

Assist the faculty in terms of secretarial assistance, documentation of records, data entry and analysis.

## 2. Nature of Engagement:

The Project Positions are purely on temporary basis in Project Mode and do not entail any form of regular appointment at NIRD&PR in future. The engagement is purely on temporary basis on contract which will be initially for a period of one year and extension can be considered based on performance and requirement of the Research Projects for another period of two years.

### 3. Age Limit

Maximum Age limit for Training Managers and Research Associates is <u>45 years</u>. Maximum age limit for project assistant is <u>30 years</u>. For Sr consultant Maximum Age limit is 65.

## a. Language:

- Fluency in English and Hindi. Knowledge of regional language(s) would be an asset.
- Good Communication Skills.

**Duration of Contract:** For an initial period of one year. Contract may be renewed based on performance. The remuneration and other benefits may be revised on renewal.
