#### Advertisement for "Consultants" under the Project 'Multi Sector Nutrition Capacity Building Initiative' - "Sangam"

NIRD&PR invites applications for two Consultants to work in a project on 'Multi sector Nutrition Capacity Building Initiative' - "Sangam" "supported by UNICEF upto December 2017. The project post is purely contractual and project based, initially for one year and will be renewed based on funding of donor and performance of the candidate.

#### **About Project:**

Government of India is constantly coming up with new schemes and programs to combat the problem of undernutrition but still children in India show a poor nutritional status. Child stunting is an irreversible and chronic manifestation of undernutrition. Importantly, it is an underlying cause of one-third of deaths among children less than five years in India. Reasons for poor nutrition status of children, are multifaceted and inter-related, including poverty induced household food insecurity, poor access to water, health and sanitation services, maternal undernutrition and poor feeding and care practices. This means that not only the health but various other sectors need to converge and layer nutrition sensitive practices in their existing programmes. Therefore this project takes the initiative to build a Multi-sector Nutrition Capacity Building module for the officials of the Ministry of Rural Development and Panchayati Raj and Seven allied departments (Drinking Water and Sanitation, Agriculture, Water and Land Resources, Tribal Welfare, Environment and Forest, Tribal Welfare and Education) in four states viz. Odisha, Jharkhand, Bihar and Chhattisgarh

To support develop, testing, evaluation and institutionalizing a nutrition-sensitive training module for Water, Sanitation, Forest, Land and Water, Rural development (NRLM), Panchayati Raj and Education Sector officials at state, district, block level in the states of Odisha, Jharkhand, Bihar and Chhattisgarh, which will be implemented through NIRD&PR for state, district and block officials of education and water sectors. The stakeholders in the water and sanitation and the Education sector will be mapped and contacted for a brainstorming workshop as part of the landscape analysis. A working group from the identified stakeholders will design the training module, after which it will be pre tested in the respective states. Consultant will escalate the work through dialogues with state and block officials in State Institute of Rural Development (SIRDs) and Extension Training Centre (ETCs) in order to percolate the nutrition-sensitive practices using the training module at the field level.
