#### Editorial

#### "Common Norms for Skill Development"

#### Dear Readers.

Government of India, Ministry of Skill Development and Entrepreneurship issued a notification No.H-22011/2/2014-SDE-1. dated 15.7.2015 which was published in "Gazatte of India" on 8.8.2015 on Common Norms for Skill Development Schemes implemented by the Govt. of India. The RSETIs are also engaged in skill development and funded by Govt, of India, Hence common norms notification is also applicable on RSETIs w.e.f. 1<sup>st</sup> April. 2017.

#### The silent features of Common Norms Notification area as follows:

- Skill development is defined as any domain specific demand led skill training activity leading to employment or any outcome oriented activity.
- For fresh entrants to the job markets, the training duration to be minimum ٠ 200 hours including practical and/or on job training.
- In case of re-skilling or skill up gradation of persons already engaged in occupation the training duration to be minimum of 80 hours including practical and/or on job training.
- In case of persons who have acquired skill through informal, non-formal ٠ or experimental training in any vocational trade or craft, formal recognition & certification if necessary after imparting bridge courses, to be treated as skill development.
- Soft skills (computer literacy, language) would be an integral part of skill training process.
- ٠ All skill development courses must confirm to the National Skill Qualification Framework (NSQF) notified on 27.12.2013 which provides for transition of all training programmes to be NSQF complaint by 27.12.2016.

#### In put standards -

- Training infrastructure and equipment should be as per industry bench  $\succ$ marks.
- Qualified trainers to be hired and to undergo Training of Trainers.  $\succ$
- Training content should be confirming to requirement of NSQF/SDIS. >
- The students and trainers enrollment to be linked to Aadhar. >
- Assessment being video recorded if required. >

#### Out comes -

- Independent 3<sup>rd</sup> party certification of skilled individual.  $\succ$
- At least 70% of the sucessfully certified trainees of within 3 months of  $\succ$ completion of training be self employed.
- In case of re-skilling or skill up gradation 70% of candidates shall have  $\succ$ increase of 3% in their income within 14 months.

#### Fund follow mechanism -

The release of funds will be batch wise as follows:

- 30% on commencement of the training batch  $\succ$
- 50% on successful certification of trainees.  $\succ$
- 20% outcome based on placements. >
