## Dr. D Veerendra Heggade visits NIRDPR

# **Brief Introduction**

Dr. D Veerendra Heggade is an individual with multidimensional capabilities. He is a reformer, educationist, philosopher and hereditary administrator / Dharmadhikari of Dharmasthala Temple in Karnataka. He succeeded to the post of Dharmadhikari at the age of 20, on 24th October. 1968, becoming the 21st Dharmadhikari of the Dharmasthala temple. In the last 47 years, he has initiated multiple pioneering social, economic and cultural projects for the development of the society.



He converted a small temple town into a modern education hub, eventually redefining the very role of temple being a place of worship to a place of service. Dr. D Veerendra Heggade was awarded India's second highest civilian award 'Padma Vibhushan' by former President Shri Pranab Mukherjee in 2015 in recognition of his outstanding services to the society. The Karnataka Government honoured him with the 'Karnataka Ratna' title in the year 2009. 'RAJARSHI' title was also conferred on him by former President Dr. Sharkar Dayal Sharma in 1993. He was also conferred with the 'Man of the Year' award by the Public Relations Society of India in 1994. Former Prime Ministers Shri P V Narsimha Rao and Shri Atal Bihari Vajpayee presented him the FICCI awards for SKRDDP in 1995 and Rural Development and Self-employment activities by RUDSETIs in 1999 respectively.

Dr. D Veerendra Heggade executes his social responsibility as a pious grahastha through four traditional daanas – Anna Daana, Aushadha Daana, Vidya Daana and Abhaya Daana. These are the traditionally observed charities of granting food, medicine, education and ensuring freedom from fear. He is regarded as the voice of Lord Manjunatha. He is expected to dispense justice, advice and munificence to whoever approaches him with their grievances.

## Dr. D Veerendra Heggade visits NIRDPR



Dr. D Veerendra Heggade visited the NIRD&PR on July 18, 2017. During the visit, he participated in a brainstorming session on 'Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) and interacted with the participants, including the mission directors of various State Rural Livelihood Mission (SRLMs), Programme Implementing Agencies (PIAs), and officials from the MoRD & NIRD&PR. In his address, Dr. Heggade spoke about the systematic need of skill development among rural youth so as to engage them in creating livelihood and shared his own experience in the field. He further visited the Rural Technology Park (RTP) at

NIRD&PR, where he interacted with the entrepreneurs. Dr. Heggade also inaugurated 'Frugal Technology Stalls' recently established in collaboration with the DRDO. He appreciated the set up of RTP and contribution made by the NIRD&PR for capacity building and nurturing the entrepreneurs. Dr. Heagade also planted a sapling of 'Artocarpus Heterophylls' outside the Vikas Auditorium at the campus.

# **Review Meeting of RSETIs**



The Ministry of Rural Development (MoRD) organised a meeting to review the performance of RSETIs on July 25, at Pusa, New Delhi. The meeting chaired by Smt. Alka Upadhyaya, IAS, Joint Secretary, MoRD, was attended by senior executives from various banks and selective Mission Directors of SRLMs apart from Shri Anil Subramaniam, Director (Skill) MoRD, Shri K N Janardhana, NDR, NACER, Shri RR Singh, DG, NAR, Shri O N Bansal, PD RSETI, NIRD&PR and State Directors of RSETIs.

Smt. Alka Upadhyaya explained the purpose of holding the meeting and requested the participants to deliberate on the strategies to be adopted to achieve the objectives of RSETIs. She emphasised four critical issues viz. infrastructure, HR/manpower policy, quality of the training and credit linkages of RSETI-trained candidates. She urged the participants to achieve a minimum of 70% placement of candidates, of which 90% under self-employment. "As the RSETIs are bank-led institutions, the candidates should not face any difficulties in credit linkages," she said and advised the States to take ownership of RSETIs and to ensure mobilisation of sufficient number of BPL candidates for training. Shri Anil Subramaniam reviewed the performance of the RSETIs, both statewise and bank-wise, through slideshows covering various parameters such as performance under AAP, training, settlement and credit linkages. During the course of meeting, various action points for implementation were emerged.

## **Editorial**

Dear Readers.

#### PFMS – Public Financial Management System

PFMS initially started as a plan scheme named CPSMS of the Planning Commission in 2008-09 as a pilot in four States of Madhya Pradesh, Bihar, Punjab and Mizoram for four flagship schemes viz. MGNREGS, NRHM, SSA and PMGSY. After the initial phase of establishing a network across Ministries/Departments, it has been decided to undertake National rollout of CPSMS (PFMS) to link the financial networks of Central, State Governments and the agencies of State Governments. The scheme was included in 12th Plan initiative of Planning Commission and Ministry of Finance.

- Total outlay of the scheme to be implemented through the O/o CGA would not be more than Rs. 1080 crore
- 2. Four-tiered project organisational structure viz.
  - a. Project Implementation Committee (PIC) at apex level
  - b. The Central Project Management Unit (CPMU) at Centre
  - c. State Project Management Unit (SPMU) at State level
  - d. District Project Management Unit (DPMU) at district level to be manned through outsourcing

#### Mandate:

The mandate given to PFMS by Cabinet decision is to provide:

- A financial management platform for all plan schemes, a database of all recipient agencies, integration with core banking solution of banks handling plan funds, integration with State treasuries and efficient and effective tracking of fund flow to the lowest level of implementation for plan scheme of the Government
- To provide information across all plan schemes/ implementation agencies in the country on fund utilisation leading to better monitoring, review and decision support system to enhance public accountability in the implementation of plan schemes.
- To result in effectiveness and economy in Public Finance Management through better cash management for Government, transparency in public expenditure and real-time information on resource availability and utilisation across schemes. The roll-out will also result in improved programme administration and management, reduction of float in the system, direct payment to beneficiaries and greater transparency and accountability in the use of public funds. The proposed system will be an important tool for improving governance.

#### Modules to implement the Mandate

Modules developed /under development by PFMS for stakeholders as per the Union Cabinet above mandate are as under:

#### I. Fund Flow Monitoring

- (a) Agency registration
- (b) Expenditure management and fund utilisation through PFMS EAT module
- (c) Accounting Module for registered agencies
- (d) Treasury Interface
- (e) PFMS-PRI fund flow and utilisation interface
- (f) Mechanism for State Governments towards fund tracking for State schemes
- (g) Monitoring of Externally Aided Projects (EAP):

#### II. Direct Benefit Transfer (DBT) modules

(a) PAO to beneficiaries (b) Agency to beneficiaries (c) State treasuries to beneficiaries

#### III. Interfaces for Banking

(a) CBS (b) India Post (c) RBI (d) NABARD & Cooperative Banks

#### **Agency Registration:**

Implementing Agencies (e.g. Statutory bodies, Trusts, Registered Societies, Autonomous Bodies, State Govt. Institutions, Local Bodies, etc.) are registered on PFMS for monitoring of bank balances and tracking of fund flow. The bank balances of these agencies can be monitored through PFMS after their registration on PFMS. Presently, 17.9 lakh agencies are registered with their bank accounts duly validated by PFMS-Core Banking Solution (CBS) Interface and used by stakeholders for monitoring purpose. Details of progress since its inception is as under:

MIS and DSS output reports are available on PFMS. State wise releases, Ministry wise Scheme wise releases, Implementation level wise bank balances for each scheme is available to the stakeholders on PFMS.

#### Expenditure management and fund utilisation through PFMS (EAT) module:

After completion of registration process, the Agencies can log onto PFMS portal and can create Maker and Checker type users to use **Expenditure-Advance-Transfer modules** (EAT module) for transferring funds or advances to lower level Agencies and e-payments to vendors, employees and beneficiaries for financial MIS. This is an extremely important functional module of PFMS for monitoring the ultimate utilisation of funds

## **RSETI Director's Conclaves**

#### **Union Bank of India**



The Union Bank of India organised the sixth round of conclave for their RSETI Directors on July 10th and 11th 2017 at Varanasi. The conclave was inaugurated by **Dr. Ravi Gupta, GM, RABD** by lighting the lamp. Shri S N Kaushik, FGM, Varanasi Zone, presided over the conclave. Shri K N Janardhana, NDR, NACER, Shri Vimalesh Jain, DGM, RABD, Shri Rajiv Mishra, Regional Head, Varanasi and Shri O N Bansal, PD RSETI, NIRDPR, Hyderabad were present on the occasion. The conclave was attended by 14 RSETI Directors, respective LDMs and regional heads controlling the RSETIs.

In his inaugural address, Dr. Gupta highlighted the objectives of RSETI and role of banks for achieving the national and social objectives. He urged the directors to take active steps for improving settlement of the trained candidates. Shri Kaushik opined that the directors need to be dynamic and vibrant to attend to the local needs and should take care of post-training assistance and skill upgradation of the trainees in previous batches. Shri O N Bansal spoke about the issues related to land allotment and construction of RSETI buildings. He assured to take up the problems faced by RSETIs ragarding allotment of land with the State government immediately.

Shri Janardhana and Shri Vimalesh reviewed the performance of individual RSETIs based on slideshows presented by respective directors. In the review, gaps hampering the efficient functioning of RSETIs were identified and various remedial measures were suggested. Shri Janardhana advised RSETI Directors to attend the identified issues on priority basis, so that the guidelines of MoRD in addressing the unemployment problem in the country can be achieved. Shri Vimalesh Jain, DGM, in his valedictory address emphasised that the skill development programmes must have greater orientation on self-employment programmes and training should be supplemented by timely credit linkages.

### **Punjab National Bank**



The Punjab National Bank organised the seventh round of their RSETI Directors conclave on July 28 and 29, 2017 at the Learning & Knowledge Management Centre (LKMC) in New Delhi. The conclave was attended by **Dr. R S Sangapure**, **Executive Director of the Bank**, Shri B M Padha, Executive Trustee/GM, Shri Anil Subramaniam, Director (Skill), MoRD, Shri K N Janardhana, NDR, NACER, Shri R R Singh, DG, NAR, Shri O N Bansal, PD RSETI, NIRD&PR, Shri S R Agarwal, DGM & Managing Trustee, Shri H S Sahal, President, PNBCRDT and Shri A K Kakkar, Nodal Executive, apart from 44 Directors of RSETIs, sponsored by the PNB.

The conclave was inaugurated by the Shri S R Agarwal, DGM and Managing Trustee. Shri Anil Subramaniam, Director (Skill), MoRD elaborated the challenges of RSETI movement and the expectations of the MoRD in socio-economic uplift of the rural poor in particular, and other rural masses in general. He said that coverage of the rural poor and their credit linkage are dismal and need to be improved. Shri S R Agarwal made a presentation on PNBCRDT and exhorted RSETI Directors to convert RSETIs into 'Centre of Excellence'. He urged that RSETIs should be made self-reliant by March 2019. Further, RSETI Directors were divided into four groups to present the action points after deliberations on the following topics: i) RSETIs — role as an agent of change for improving milieu of rural life, ii) Approach needed to make RSETIs a Centre of Excellence, iii) Ways to boost settlement rate with focus on credit linkages iv) Adopting pragmatic approach for implementation of common norms.

Shri B M Padha elaborated the concept of RSETI movement and urged the directors to work with missionary zeal. Dr. R S Sangapure sensitised the RSETI Directors on measures for boosting the settlement rate and improving the credit linkages of the trainees. He urged the directors to find wage and mean for percolating the benefit of RSETIs to the needy. Shri Janardhana explained in detail the operational and functioning aspects of the RSETIs. Shri Singh elaborated on adoption of the common norms and improving the quality of training as per NSQF. Shri Bansal reviewed the progress made by the bank in construction of RSETI buildings in various locations.

### **Indian Bank**

सिंड आरसेटी मेरठ में निशुल्क "फैशन डिजाईनिंग" में आवेदन कर साक्षात्कार के पश्चात उसे प्रशिक्षण के लिए चुन लिया गया। प्रशिक्षण की अवधि के दौरान उसने नये प्रकार के वस्त्रों को डिजाईन करना एवं काटना व सिलाई के बारे में जाना तथा प्रशिक्षण में उसे व्यवसाय की बारीकियों के बारे में जानकारी दी गयी। संस्थान के निदेशक एवं प्रशिक्षकों ने एक सफल उद्यमी की योग्यताओं के बारे में जानकारी दी।

प्रशिक्षण के पश्चात् मवाना में "फैशन डिजाईनिंग" के कार्य की शुरूआत रू. 25,000/- से की। आज उसकी शुद्ध मासिक आय रू. 12,000/- है। श्रीमती ज्योंति का पूरा परिवार सिंड आरसेटी मेरठ को धन्यवाद देता है जिसने उसके सपने को मात्र 30 दिन में नया आयाम दिया है एवं जीवन की राह को स्गम बना दिया।

## **Success stories**

### SBI RSETI Malakangiri, Odisha



**Shri Gopal Ray,** aged 28 years, is the son of Sri Goura Ray of M V 19, Malkangiri in Odisha. He studied up to 9<sup>th</sup> standard. Belonging to a poor family with low monthly income, Gopal Ray says his parents were unable to meet the even basic requirements of life. He wished to launch a self-employment venture keeping in view the demand of local market.

He had a strong desire to succeed in life and prove his potential. Initially, he started a tailoring unit at Malkangiri. He faced a lot of struggles to establish the unit due to financial constraints. After a long period, he

made contact with SBI RSETI Malkangiri and came to know the details of the training programme offered by it. He approached the institute and expressed his desire to become an entrepreneur and provide employment to other rural youth as well.

Further, sensing the scope, he joined the mobile phone servicing course. During the training, he acquired skills and learned various techniques of the vocation. After successful completion of the course, he opened a mobile phone service shop with his own investment of Rs. 90,000 at M V 19, Malkangiri. Today, he is a proud owner of a mobile phone sales and service shop and earns Rs. 9,000 per month. He fondly remembers the helping hand extended by RSETI in shaping his career and coveys his gratitude to the SBRSETI Director and staff from the bottom of his heart.

# **ICICI RSETI Udaipur, Rajasthan**



Shri Bheru Lal Gadari hails from an agricultural family with poor financial backgrounds. Bheru, the youngest of all the siblings, maintained a carefree attitude to an extend. The financial condition of the family was so weak that the members were struggling to make both ends meet. Owing to the situation, he could not study beyond 10<sup>th</sup> grade. As Bheru was thinking about his future plans, one of his friends told him about ICICI RSETI and gave him a pamphlet bearing the details of the training programmes. As he went through the pamphlet, he came across a training course on two-wheeler servicing.

Soon, he approached the nearest ICICI Satellite centre in Bhinder block and got himself enrolled for the course. The training imparted him not just technical knowledge but also the entrepreneurship skills and financial literacy. In fact, these add-ons gave him the much-needed confidence. "At ICICI, the RSETI staff and teachers encouraged me to start my own enterprise", Bheru says. After training, he opened a two-wheeler repairing and servicing shop. Today, he is making a decent earning of Rs.18,000 per month. Aiming to expand his business, Bheru has also applied for a loan. The guidance from the financial literacy session arranged by ICICI RSETI has also helped him to make little savings. "Today, I am financially secure and attending needs of my family heads".

## Dena RSETI Bhuj Dist. Kutch, Gujarat



Mrs. Manisha Suthar, a woman from Rajasthan, nursed the dream of becoming a beautician with the support of her family. She completed her education till Class 12. After marriage, she shifted to Bhuj with her husband Shri Aswin Kumar. She told her husband about her dream job and he offered her full support. Incidentally, she saw an RSETI advertisement regarding training programme on Beauty Parlour Management. She applied for the course and got selected after an interview. In the first two days of training, she got

to know about the self-employment opportunities. She learned a handful of new techniques in beauty treatment during the technical training sessions and completed her training at RSETI successfully.

Later, Smt. Manisha started her beauty parlour at her home with an investment of Rs.50,000. She also developed a marketing strategy by installing a signboard in nearby area and advertising widely about her unit on social media and also started offering discounts. Smt. Manisha Suthar is now receiving good response from the local residents. She is also planning to expand her business and organise a free workshop. At present, she is making a monthly net profit of Rs.7,000. Smt. Manisha thanks the RSETI team for the motivation, training and assistance to realise her dreams.

### SBI RSETI Karimnagar, Telangana



**Smt. Sidda Leela** is a 28 years old, middle class woman from Mutharam (Vill & Mndl), Karimnagar district in Telangana, who studied up to 10<sup>th</sup> standard. By chance, she came to know about SBI RSETI, Karimnagar through EAP conducted at Mutharam Village by the RSETI staff. She attended the same and enrolled her name for the tailoring course for women. After the successful completion of the one-month training that started on April 6, 2017 and ended on May 7, 2017, she launched a tailoring unit at her home

Jeevana Jyothi Ladies Tailors' by investing Rs.50,000. She started taking order to stitch garments for women and children. As her sewing skills made her popular in the village, she is getting more orders now.

At present, she runs a successful business and earns a monthly income of Rs.10,000. She also has received orders from private agencies for stitching uniforms for school children. Smt. Sidda Leela expresses her sincere gratitude to the SBI RSETI, Karimnagar and its staff.
